Terms & Conditions

- 2. This program is exclusively available to selected CLP registered residential customers who are active smart meter user for a minimum of 13 months.
- 3. Participants who move out from the household will lose the qualification to participate CLP Eco-Grade.

As per the Hong Kong Personal Data (Privacy) Ordinance, we are only permitted to send you marketing communications with your explicit direct marketing consent. Therefore, if you have not provided CLP such consent or have opted out from existing consent, we will then refrain from sending you pilot program communications with marketing information.
