

How to Read Your Electricity Bill

Applicable to Residential Tariff Customers

Bill Type: Normal Bill

1 Recipient and Postal Address

Your recipient's name and postal address. Postal address can be different from electricity supply address

2 Tariff Type

Your electricity bill belongs to:
 Residential Tariff

3 Energy Charge

Your Energy Charge is calculated according to electricity consumption and consumption rate

4 Fuel Cost Adjustment

The Fuel Cost Adjustment is updated once a month to reflect fuel price changes timely, and is published on the CLP website: <https://e.clp.com.hk/fca-en>

5 Consumption History

Your average daily electricity consumption in the past 14 bills

6 Bill Message

Important information that we would like to communicate with our customers

7 Registered Customer & Supply Address

Your registered customer name and the electricity supply address

8 Account Number

Your unique electricity account number for bill payment and enquiries

9 Deposit

The security deposit paid for your electricity account

10 Others

This covers other charges and rebates, excluding Energy Charge and the Fuel Cost Adjustment

11 Total Amount & Due Date

$3 + 4 + 10 = \text{Total Amount}$
Please settle your bill on or before the due date

12 Meter Number & Meter Reading Records

Units of electricity consumption are calculated using this formula:
(Present Meter Reading - Previous Meter Reading) x Multi Factor

13 Government Electricity Charges Relief Scheme (ECRS) and Electricity Subsidy (ECSS)

14 FPS QR Code

15 Environmental Information
